#### Charged U/s 419, 353, 506(i) IPC r/w 34 IPC

The above noted accused are all friends and associates. They all in an association misusing the name of the Govt. Human Rights Commission.

On 15.08.2010 at about 20.00 hrs, when Tmt.V.Roselin Savio, the Sub -, Inspector of Police of Veeravanallur Police Station was on duty at her office room discharging her official duty at the Police Station, Veeravanallur all the above noted accused intentionally made an entry in to the room of the Sub Inspector of Police at Veervanallur Police Station fraudulently posing themselves as if they are coming from Govt. Human Rights Commission and authantatively demanded the documents in a threatening manner relating to one Suresh of Kottaivasal Street, Veeravanallur, who was detained under Goondas Act.

When the Sub Inspector of Police, asked the above noted accused about their identity, the accused told her that they all coming from Govt. Human Rights Commission and when the Sub Inspector of Police asked the accused to show their identity cards, they not only refused but started threatening the Sub Inspector of Police with dire consequences.

All the five accused again and again emphasized and impersonated themselves as Government officers as if they are coming from Govt. Human Rights Commission and behaved with the Sub Inspector of Police in a threatening manner and prevented her from discharging her official duties.

All the five accused threatened the Sub Inspector of Police raising their voices and pointed their fingers near the face of the Sub Inspector of police and with gestures and roaring voices made her frightened. Further, all the accused blamed the Sub Inspector of Police that Veeravanallur police are detaining innocent people under Goondas Act. All the accused above noted caused alarm to the Sub Inspector of Police by stating that if she did not hand over the records, they will inform the authorities and will endanger her future carrier and job.

?

Alarmed by the acts of all the five accused, Sub Inspector of

Police escaped out of her room and conveyed the incident to her experior officer.

All the five accused intentionally made an entry into the roll refine women Sub Inspector of Police and impersonating themselves as Govt. officers of the Govt., Human Rights Commission and made the Woman Sub Inspector of Police Tmt.Roselin Savio to believe that they were the officers of National Human Rights Commission and on that pretext intentionally induces the Sub Inspector of Police so deceived to provide the documents which they required and which Act she would not do if she were not so deceived by such impersonation and thus cheated the Woman Sub - Inspector of Police cheating the Sub - Inspector of Police, a public servant.

Hence A1 to A5 are liable to be prosecuted for having committed offences punishable under sections 419, 353, 506 (i) r/w 34 IPC for entered into the office of the Woman Sub Inspector of Police and deterring a public servant from discharging her official duties and also for threatening her and criminal conduct of intimidating her with dire consequences and trying to assault her.

Hence this charge.

Some of these organizations have registered themselves having similar acronym or logo with an intention to mislead the public.

- 2. The Commission has neither a provision for registration, affiliation of the individuals/NGOs/organizations nor authorize any one to act on its behalf. The individuals/NGOs/organizations using the NHRC logo, name or writing 'Having association with NHRC' or words to the effect misleading the public by misusing the name of the Commission will render themselves liable for legal action.
- 3. The name and logo of the National Human Rights Commission has been listed in the Schedule of Emblems and Names (Prevention of Improper Use) Act, 1950 under entry number 26 and 27. The improper use/misuse of the logo and the name of the Commission is punishable as per the Act.
- 4. The Commission has written to Chief Secretaries of States and UTs to take strict action against such individuals/NGOs/organizations misusing the name and bgo of the Commission and misleading the public.

However, the practice of misusing the name and logo of the NHRC by the ndividuals/NGOs/organizations is unabated and Commission has taken serious note of it. To check misuse of the name and logo of the Commission, you are requested or

- direct all DMs/SSPs to take immediate action against such individuals/NGOs/organizations who are found misusing the name and logo of the Commission and ensure that nobody misuses the name and logo of the NHRC for personal gains and action taken report may be sent to NHRC,
- (b) \_\_direct Registrar of Societies in the State not to register any organization having similar name/acronym/logo as NHRC, India.

(c) give wide publicity in the local electronic and print media that there is no provision for registration, affiliation of the Individuals/NGOs/organizations with the National Human Rights Commission and Commission does not authorize any one to act on its behalf. The individuals/NGOs/organizations misusing the name and logo of the NHRC will invite legal action against them.
